AGREED PERMANENT INJUNCTION AND ORDER OF PARTIAL DISMISSAL

Having considered the Stipulation for Entry of Agreed Permanent Injunction and Order of Partial Dismissal filed by Plaintiff DISH Network L.L.C. and Defendants TV Net Solutions, LLC and Mohammad Mustafa, the court file in this matter, and the applicable law, the Court approves the stipulation and **ORDERS** as follows:

(1) Defendants TV Net Solutions, LLC and Mohammad Mustafa, and any of their officers, agents, servants, employees, attorneys, or other persons acting in active concert or participation with any of the foregoing that receives actual notice of this order, are hereby permanently enjoined from:

A. advertising, distributing, broadcasting, performing, or providing any equipment or service that enables access to any of the following channels, including any content that airs on the channels, during any period for which DISH Network L.L.C. owns or holds the exclusive right to distribute, broadcast, perform, or provide any of these channels or the content that airs on these channels: Aghapy TV, Al Arabiya, Al Hayat 1 also known as Al

Hayah 1, Al Hayat Cinema also known as Al Hayah Cinema, Al Yawm, Al Zikr, ART America, ART Movies, Dream 2, ESC, Future TV, Hekayat, IQRAA, MBC, MBC Drama, MBC Kids also known as MBC3, MBC Masr, Murr TV also known as MTV, New TV also known as Al Jadeed, Nile Drama, Noursat, ONTV, OTV, Rotana America, and any other channel or content to which DISH Network L.L.C. holds exclusive distribution or performance rights (collectively, the "Infringing Programming");

B. providing any television equipment or service supplied by co-defendants Global Satellit IP TV Scandinavian AB or Basem Halabi, or non-party Advanced TV Network Sweden AB, that is used to access the Infringing Programming.

(2) To be clear, Defendants TV Net Solutions, LLC and Mohammad Mustafa are enjoined from advertising, distributing, broadcasting, performing, or providing any equipment or services that enables access to the Infringing Programming, regardless of how the Infringing Programming is acquired, where the Infringing Programming is acquired, and regardless of whether all or part of the Infringing Programming is made available directly or by a third party, for free or otherwise, in the United States or any other territory.

(3) This permanent injunction takes effect immediately.

(4) The Court is informed that Plaintiff DISH Network L.L.C. and Defendants TV Net Solutions, LLC and Mohammad Mustafa have agreed to a settlement sum, and therefore no damages are awarded in this order.

(5) As between Plaintiff DISH Network L.L.C. and Defendants TV Net Solutions, LLC and Mohammad Mustafa, each party will bear its own attorney's fees and costs.

(6) Plaintiff DISH Network L.L.C.'s claims asserted against Defendants TV Net Solutions, LLC and Mohammad Mustafa are dismissed with prejudice.

(7) The Court retains jurisdiction over this action for a period of two years for the purpose of enforcing this permanent injunction and order of partial dismissal.
